Domestic Violence Inventory 10 Year (1997 – 2006) Research Report

This report summarizes Domestic Violence Inventory (DVI) test data for **981** domestic violence offenders. The DVI test data was gathered between January 1997 and January 2006. The DVI is described on the Risk and Needs Assessment website at **www.riskandneeds.com**. This report is provided by Risk and Needs Assessment, Inc., P.O. Box 44828, Phoenix, AZ 85064-4828.

Introduction

This report summarizes Idaho Domestic Violence Intervention Center test data contained on diskettes returned to Risk & Needs, Inc. through August 15, 2006. This report includes data from **981** domestic violence offenders who took the Domestic Violence Inventory (DVI) between January 1997 and January 2006. The table below shows the number of offenders tested by year.



The report analyzes offender demographic and self-reported court history statistics. The report also presents validity, reliability and accuracy analyses of the Domestic Violence Inventory.

Demographic Information _____

Gender of Offenders Tested




Sex of the Offender

Based on diskettes received as of August 2006, a total of **981** domestic violence offenders were tested with the Domestic Violence Inventory (DVI) from January 1997 to January 2006.

- 81% were male
- 19% were female

In 2005, 241 offenders were tested. Of those, 190 (78.8%) were male and 51 (21.2%) were female.

Race of Offenders Tested



Race of Offender


Overall, of the 981 domestic violence offenders tested during this period,

- 65.3% (617) were Caucasian
- 17.5% (165) were African-American
- 13.4% (127) were Hispanic
- 3.8% (36) were of "other" (Native American, Asian, etc.) races.

Of the 241 domestic violence offenders tested during 2005: 171 (72.8%) were

Caucasian, 25 (10.4%) were Black, 37 (15.4%) were Hispanic and 7 (2.9%) were of "other" races.

Age of Offenders Tested _____




Age of Offender

The average age of the 981 domestic violence offenders tested with the DVI during this period was 32.1 years. Other age statistics of interest include:

• There was no significant difference in average age by gender, or race/ethnicity.

Of the 241 domestic violence offenders tested during 2005, the average age was 31.5 years.

Offender Educational Attainment



Educational Attainment


Overall, half (52.2%) of 981 offenders tested had less than a High School education. Twentynine percent (28.8%) had a High School diploma or GED, and 10.8% had some education beyond high school.

 16.7% of female offenders, compared to 9.5% of male offenders had post-high school education

Of the 241 domestic violence offenders tested during 2005, 66.7% did not have High School diplomas or GED's, 33% had high

school degrees, and none had post-high school education.

Offender Marital Status




Nearly forty-seven percent (46.7%) of the 981 domestic violence offenders tested with the DVI during the six year period were married (including married offenders currently separated from their spouse). Singles made up 36.4%, while 10.9% were divorced and 5% were widowed.

• There were no significant differences in marital status with respect to gender or race.

Of the 241 domestic violence offenders tested during 2005, 55.5% were married/ separated, 32.9% were single and 20.4% were either divorced or separated.

Age at 1st Conviction _




Age of Offender at 1st Conviction

The average age of the 981 domestic violence offenders at first conviction was 22.2 years. Other age statistics of interest include:

• The average age for Caucasians was 22.4 years; for Blacks, 21.2 years; and for Hispanics 24.3 years (t=1.07, p<.05).

Of the 241 domestic violence offenders tested during 2005, the average age was 25.0 years.

Domestic Violence Arrests



Domestic Violence Arrests

Nearly eighty percent (79.4%) of the 981 domestic violence offenders tested were first time offenders.


Of the 200 multiple offenders, 125 (62.5%) had two domestic violence arrests and 75 (37.5%) had three or more domestic violence arrests.

- Males were more likely to be multiple offenders than females, 23.3% vs. 9.3% (t=1.9, p<.06)
- There was no significant difference in the overall percentage of multiple offenders by

race/ ethnicity.

Of the 241 domestic violence offenders tested during 2005, 200 (83.0%) were first-time offenders and 41 (17.0%) were multiple offenders. Twenty percent (20.0%) of males were multiple offenders but there were no female multiple offenders.

Alcohol-Related Arrests



Alcohol Related Arrests

Just over half (54.2%) of the 981 domestic violence offenders tested with the DVI reported no prior alcohol-related arrests.

Among the remaining 438 offenders, 230 (52.5%) had 1 prior alcohol-related arrest, 95 (21.7%) had 2 prior alcohol-related arrests and 113 (25.8%) had three or more alcohol-related arrests.


 Males were more likely to have had prior alcohol-related offenses than women;
49.8% (Males) vs. 28.2% (Females) (t=4.7,

p < .000)

• There were no significant differences in the rates of alcohol-related arrests by race.

Of the 241 domestic violence offenders tested in 2005, 145 (60.2%) reported having had no prior alcohol-related arrests. Among the remaining 96 offenders, 47 (19.5%) had 1 prior alcohol-related arrest and 49 (20.3%) had 2 or more prior alcohol-related arrests. Over forty percent (41.5%) of male offenders in 2005 had previous alcohol-related arrests, compared with one third (33.3%) of female offenders.

Assault Arrests



Assault Arrests

Seventy-seven percent (77.0%) of the 981 domestic violence offenders tested reported no previous arrests for assault.


Of the 220 domestic violence offenders who had had a previous assault arrest, 140 (63.6%) had 1 previous assault arrests and 80 (36.4%) had two or more assault arrests.

 There was no significant difference in the percentage of males and females who had been arrested for assault.

• Black offenders (29.4%) and Hispanic offenders (24.8%) had slightly higher rates of assault arrests than Caucasian offenders (20.6%) (t=2.2, p<.05). Note that this is a weak correlation and it may be a result of race in combination with other factors (e.g. socio-economic status) not studied here.

Of the 241 domestic violence offenders tested during 2005, 182 (75.5%) had no assault arrests and 40 (24.5%) had 1 or more assault arrests.

Total Arrests



Total Arrests

Nearly forty percent (38.2%) of the 981 domestic violence offenders tested reported their current arrest was their only arrest during the past 10 years.

Another 20.1% reported a total of two arrests and 41.7% reported 3 or more arrests during the past 10 years.

- Males had significantly more arrests, on average, than females, 3.5 compared to 1.9 (t=6.7, p<.000)
- Caucasian offenders had fewer arrests(3.0),

on average, than Black offenders (3.8) or Hispanic offenders (3.4) (t=2.0, p<.05).

Of the 241 offenders tested with the DVI during 2005, 113 (46.9%) reported their current arrest was their only arrest during the past 10 years. Forty-seven offenders (19.5%) reported 2 total arrests, and 81 offenders (33.6%) reported 3 or more arrests during the past 10 years.

Domestic Violence Inventory (DVI) Test Statistics _____

The following pages present Domestic Violence Inventory (DVI) test statistics. This analysis supports the DVI as a reliable, valid and accurate domestic violence offender assessment instrument. A test cannot be valid without being reliable, and test accuracy is required for accurate referrals for intervention and treatment.

Validity_____

Predictive validity measures how well scale scores distinguish between offenders with known problems in a given area and those who had no known problems in that area. For instance, offenders who had been treated for alcohol abuse would be predicted to have higher scores on the Alcohol Scale than offenders who had not been treated for alcohol abuse.


Concurrent validity testing is used to show a correlation between the test and a known criterion. The criterion used to determine concurrent validity is often another test that measures the same thing. This type of validation has been conducted in several studies on DVI scales. These studies are presented in the document titled, "DVI: An Inventory of Scientific Findings," which can be provided upon request.

Ninety-nine percent (98.9%) of the offenders who had been treated for drinking problems had scores placing them in the High Risk (70th percentile and above) range on the Alcohol Scale. All offenders (100%) who had been treated for drug problems scored in the High Risk range on the Drugs Scale. Ninety-four percent (93.8%) of the offenders who admitted they were violent scored within the Violence Scale High Risk group. Ninety-eight percent (100%) of the offenders who admitted they were too controlling in their relationships with others had scores in the High Risk range on the Control Scale. These results support the predictive validity of the Domestic Violence Inventory (DVI).

Accuracy _____

The four Domestic Violence Inventory (DVI) risk ranges (low, medium, problem and severe) and the predicted percentages for each risk range category are shown in parentheses in bold print in the top row of the table below. The percentages for each DVI scale and risk range category were obtained from the offenders attained scale scores.

All but 3 of the obtained risk range percentage were within 2.8 percentage points of the predicted percentage. Accuracy of the DVI is shown by the small differences between obtained risk range percentages and predicted percentages. **The DVI can be considered 97% accurate.** The DVI is an accurate domestic violence offender assessment test.

Reliability

Reliability coefficient alphas for the DVI. All alphas are significant at p<.01. (N=981)

All DVI scales have reliability coefficients of .89 or higher. The professionally accepted reliability standard is .75 and higher. **All DVI scales can be considered highly reliable.**

Summary

Data for this report was obtained from diskettes that were returned through August 15, 2006. The DVI was administered to **981 domestic violence offenders** between January, 1997 and January, 2006. There were 794 males (81.0%) and 186 females (19.0%). The offender population is broadly defined as Caucasian (65.2%), 20 through 39 years of age (54.6%), High School or less education (89.1%), and evenly split between single, married and divorced/separated/widowed.

DVI Accuracy, Reliability and Validity

- DVI scales demonstrate a **high degree of predictive validity**, accurately classifying known high risk offenders in the appropriate problem risk range.
- All DVI scales reliability coefficients were **.89 or higher.** This compares favorably with the professionally accepted reliability standard of .75 or better.
- DVI risk ranges were shown to be **97 percent** accurate. This is accurate assessment.

DVI scale score risk ranges are stable and show that the Domestic Violence Inventory (DVI) continues to accurately assess offender risk. High reliability is maintained in the DVI. These statistics support the scientifically sound methodologies of the DVI. The DVI is a reliable, valid and accurate test.
