TRUTHFULNESS SCALE: LOW RISK RANGE RISK PERCENTILE:39 This is an accurate Self-Audit profile. All scale score are accurate. This individual responded to test items in a non-defensive, cooperative and truthful manner. This client was truthful while completing the test and has adequate reading skills. The Truthfulness Scale identifies self-protective, recalcitrant and guarded people who attempt to minimize their problems or fake good. This is a low risk (zero to 39th percentile) range score.

RESISTANCE SCALE: LOW RISK RANGE RISK PERCENTILE:13 With regards to the Resistance Scale this is a low risk score. This individual is usually nonresistant or cooperative. A positive orientation to accepting help, assistance and guidance is indicated. Low risk individuals are described as friendly, accepting and cooperative. Under "normal" conditions this client can be expected to be cooperative.

VIOLENCE SCALE: PROBLEM RISK RANGE RISK PERCENTILE:75 Violent tendencies are evident. This person's score on the Violence Scale is in the Problem Risk (70 to 89th percentile) range. Problem risk scorers commit varying degrees of verbal, emotional and physical abuse. They need to learn alternatives to anger and violence. Anger management classes or group counseling could help. Also, other Self-Audit scale scores could exacerbate violence when they are elevated (above the 70th percentile).

ALCOHOL SCALE: LOW RISK RANGE RISK PERCENTILE:28 Few, if any, indicators of alcohol (beer, wine or liquor) abuse are evident. Alcohol use, if present, may be historical or represent minimal involvement. On the Alcohol Scale this client scored in the Low Risk (zero to 39th percentile) range. A person who does not presently drink may score higher than zero due to prior history, but still would score in the Low Risk range.

DRUGS SCALE: LOW RISK RANGE

Few, if any significant indicators of illicit drug use or abuse are evident. Drug involvement may be historical, experimental or minimal. A person who does not use drugs may score above zero due to his/her drug history, but would still score in the low risk range. Drug abuse risk is low. With regard to the Drugs Scale, this is a low risk score.

DISTRESS SCALE: MEDIUM RISK RANGE RISK PERCENTILE:68
This individual's Distress Scale score is in the Medium Risk (40-69th percentile) range. Medium risk scorers reflect growing unhappiness, anxiety and discouragement. This client's family and interpersonal relationships are likely contributing to their experienced distress. If talking to this person about their experencial distress does not help, then consideration might be given to group counseling.

MORALE SCALE: MEDIUM RISK RANGE

This client's Morale Scale score is in the Medium Risk (40-69th percentile) range. Although generally stable, situation specific mood swings can be anticipated. During these mood swings, this client will be more pessimistic and manifest a negativistic attitude. Interpersonal relationships will also suffer.

SELF-ESTEEM SCALE: MAXIMUM RISK RANGE RISK PERCENTILE:96 There are unusual qualities to this client's rejection and disapproval of self which may involve serious emotional problems. This score may indicate confusion, guilt, suicidal ideation, or an attempt to portray self negatively (fake bad). STRESS COPING SCALE: PROBLEM RISK RANGE RISK PERCENTILE:87 This is a Problem Risk (70 to 89th percentile) Stress Coping Abilities Scale score. #### RESPONSE CONSISTENCY/INCONSISTENCY

The Truthfulness Scale score shows whether or not Self-Audit scale scores are accurate or inaccurate. Each Truth-Corrected scale score then demonstrates the severity of the attitudes/behaviors measured. Yet, even with these important measures its sometimes informative to review pattern of responding within a scale or measure. However, it is important to understand that reported inconsistencies does not weaken or change a scales reported risk level score.

Several scale consistency reviews follow.

# ALCOHOL

Alcohol Scale items refer to current drinking problems. Response consistency would involve three admissions or denials. This client did not admit to items #75, 81 or 150. Two Alcohol Scale items (#54 and 148) relate to 'recovering' alcoholism. Agreement between these answers is expected. This client, denies being a "recovering" person. A similar theme , i.e., alcohol treatment, is present in items #87 and 151. The respondent denies having had alcohol-related treatment.

#### DRUGS

Drugs Scale items (#49, 90 and 152) refer to current drug problems. Response consistency would involve three admissions or denials. This client admitted to none of these items. Two items (#57 and 148) apply to "recovering" drug abuser. Agreement between these answers is expected. This client denies being a "recovering" person. Items #77

and 153 both pertain to drug treatment. This individual denies having had drug-related treatment.

#### DISTRESS SCALE

Distress Scale Items #27 and #159 refer to treatment and similar answers are expected. This client denies having been in treatment. The Distress Scale incorporates a suicide/homicide (#157) item and several related items. (e.g., 69, 76, 88, 97, 107 and 112). Of these similar items, this individual answered the following items in a problematic (deviant) manner: #69, 88, 112. These answers magnify this client's growing desperation.

#### RESISTANCE

Several items in the Resistance Scale reflect opposition (resistance) to help. These items include #25, 32, 41, 53, 59, 67, 74, and 89. The client's responses to these items are set forth in the "Self-Audit Responses" summary at the end of the report. A more generalized "resistant attitude" or "oppositional outlook" is reflected in the client's answers to items #44, 79, 104, 106, and 124(1 or 2). This individual answered items 53, 124 in a negativistic or noncompliant manner.

#### VIOLENCE

With regard to the Violence Scale the client's answer to item 157 (suicidal / homicidal) is important when assessing a persons dangerousness to self and/or others. When a person responds to item 157 by selecting 1 (suicidal), 2 (homicidal) or 3 (suicidal/homicidal) it's interesting to note how he answered similar or compatible items, i.e., #29, 50, 70, and 105. This client answered items 29 in a negativistic or deviant direction.
